- Submission of application after the deadline will not be accepted.
- Each project (parts or whole) is entitled to apply for one award category only.
- For those who fail to follow the provisions of the regulations, according to the level of seriousness of a breach and subject to the decision of the assessment committee, the DSEJ will consider abrogating their right to participate in the Scheme and win any prize as well as depriving them of the prize that they have won; such arrangements will be implemented with retrospective effect.
